Yupiit School District is accepting sealed bids for the furnishing, purchasing, & shipping of Food Service Products **for Akiachak, Akiak, and Tuluksak schools**. All items are to be labeled individually for each of the specific villages.

All schools are located in remote rural Alaska and none are accessible by road.

This scope of work will include the purchase, furnishing, scheduling of Product to all three of YSD Sites. These products will be individually labeled for each specific location.

All vendors who choose to bid on RFP-003, need to ensure that all products will be available and delivered at least two weeks after receipt of the purchase order.

Instructions to Bidders

1. Purpose

It is the intent and purpose of this **Request for Proposals** to solicit proposals for the furnishing of **Food Service** for the **Yupit School District at the locations of Akiak, Akiachak and Tuluksak, Alaska.**

2. The Purchaser

Yupit School District will enter into a Contract with its selected Supplier, covering the all scopes of work identified in this Request for Proposals.

3. Contract Term

The term of the Contract(s) shall be for a period of commencing on August 1, 2024 and expiring on May 30, 2025.

4. Instructions to Potential Suppliers

- a. Potential Suppliers are instructed to use the attached **Bid Tabs** for submission of proposals. These documents, as submitted in the selected proposal, will be attached to and be incorporated into the final written purchase order with the **Yupit School District.**
- b. First delivery shall be by August 16, 2024 and for the continuation of the 2024-2025 fiscal school year.
- c. The Proposal identifies locations in the State of Alaska that are accessible by waterway.
- d. In case of error in the extensions of prices in the proposal, the unit prices will govern.
- e. For the purpose of evaluating the proposals, price and contract term, offers made in accordance with the Request for Proposals shall be good and firm for a period sixty (60) days from the date of proposal opening unless the potential Supplier specifically limits their offer to a shorter period by written notification on the proposal documents. However, proposals so modified may be rejected.
- f. **Yupit School District** shall not under any circumstances be liable for any costs incurred by the Potential Contractor in proposal preparation, including in the event of the rejection of all proposals.

- h. Proposal opening is scheduled for **Friday, April 5, 2024**. All bids will be opened on that date. Bid review and notice of award shall occur within 7 days of the bid opening date.
5. Basis for Selecting Successful Proposals
- a. In selecting the Contractor for the project, **Yupiit School District** will take into consideration: product; price; past performance; deviations from proposed contract terms; and the overall best value. The intent is to award all scopes of work at all three schools to a single Contractor. Partial awards of this Request for Proposals will not be considered by the school district.
 - b. A Proposal will likely not be selected by **Yupiit School District** when:
 - i. The Potential Contractor has failed to perform satisfactorily on a previous contract with **Yupiit School District** or in the **Yupiit School District's** opinion, is not in a position to perform the contract.
 - ii. The Proposal Documentation are not signed and notarized.
 - iii. The proposal materially changes the price calculations method of Price Index (such as referencing the Contractor's own posted price list or the fuel supplier's posted price list)
 - iv. In **Yupiit School District's** sole determination, the Potential Contractor makes other material changes in the specifications or terms and conditions of the Request for Proposals.
 - c. **Yupiit School District** reserves the right to reject any and all proposals, to waive deviations from the RFP and to waive any informality in proposals received whenever such rejections or waiver is in the best interest of **Yupiit School District**, and unless otherwise specified by the Potential Contractor, to accept any items in the Proposal.
 - d. Proposals must clearly show the proposed cost for each location.
6. Optional Inclusions
- a. Prompt Payment Discounts. Prompt payment discounts shall be considered in the evaluation of this Request for Proposals such as: 2% discount if paid within fifteen (15) days after receipt and acceptance at destination and receipt of a payable invoice delivered to **Yupiit School District**.
 - b. The offered discount of the successful Contractor(s) will form a part of the Contract. Discounts based on less than fifteen (15) days' time for payment will not be considered for evaluation purposes.
